A RESOLUTION AUTHORIZING THE APPROVAL OF THE SEPARATION AND RELEASE AGREEMENT WITH THE CITY OF BATAVIA AND TRICIA ORDAZ

WHEREAS, the City of Batavia desires to enter into a separation and release agreement with employee, Tricia Ordaz; and

WHEREAS, employee, Tricia Ordaz, resigned her employment with the City effective December 16, 2022.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BATAVIA, KANE COUNTY, ILLINOIS, as follows:

SECTION 1: That the City Administrator is authorized to sign and execute the Separation and Release Agreement.

SEPARATION AND RELEASE AGREEMENT

This Separation, Waiver and Release Agreement (the “Agreement”) is made and entered into by and between Tricia L. Ordaz on behalf of herself, her spouse, family, agents, representatives, attorneys, assigns, beneficiaries, heirs, executors and administrators (hereinafter collectively referred to as “Ms. Ordaz”), and the City of Batavia, on behalf of itself and its elected officials, officers, directors, attorneys, insurers, fiduciaries, agents, employees and other legal representatives (hereinafter collectively referred to as “the City”).

1. Voluntary Resignation. By signing this Agreement, Ms. Ordaz hereby immediately resigns her employment from the City for personal reasons, and the City accepts her resignation. The parties agree that Ms. Ordaz has no reinstatement rights and Ms. Ordaz promises not to seek reemployment with the City in any position.

2. Separation Benefits. If Ms. Ordaz signs and does not revoke this Agreement, the City agrees to do the following:

- Assuming Ms. Ordaz elects COBRA continuation benefits, the City shall pay one hundred percent (100%) of the premiums for the single health, dental and vision insurance coverage (in which she participated on her last day of employment), for the time period January 1, 2023, through June 30, 2023. Beginning July 1, 2023, Ms. Ordaz will be entitled to continue her health insurance coverage at her own cost pursuant to COBRA. Ms. Ordaz acknowledges that she is not otherwise entitled to the aforementioned payment of her health insurance premiums for these six months. Notwithstanding the foregoing, the payment of the aforementioned premiums will not begin until after the expiration of the revocation period described in paragraph 6(f) of this Agreement.
- Pay her the total gross lump sum of seventy-two thousand eight hundred and forty-eight dollars and forty-four cents (\$72,848.44) The aforementioned gross lump sum amount will be subject to any withholdings that are otherwise required by law. The aforementioned gross lump sum amount approximates the total cash value of the following individual benefits (which are set forth for demonstration purposes only; the parties expressly agree that the aforementioned gross lump sum controls over any calculation errors found in the following individual benefits):
 - Fourteen (14) weeks of severance pay (which approximately equals \$25,104.69);
 - Two hundred (200) hours of vacation that would accrue on January 1, 2023 (which approximately equals \$8,965.96);
 - Eight (8) hours of personal leave that would accrue on January 1, 2023 (which approximately equals \$358.64);
 - Forty percent (40%) of accrued sick leave on January 1, 2023 (which approximately equals \$19,545.80); and
 - Four hundred and twenty-one (421) banked vacation hours and pro-rata vacation separation benefits (which approximately equals \$18,873.35).

The aforementioned payment will be issued at the end of the next full payroll period following Ms. Ordaz's last day of employment, absent revocation of this agreement by Ms. Ordaz.

3. Application for Unemployment Insurance. Assuming Ms. Ordaz signs and does not revoke this Agreement, the City will not contest an initial application for unemployment insurance benefits submitted by Ms. Ordaz to the Illinois Department of Employment Security ("IDES"). However, the City cannot promise or otherwise guarantee that the IDES will grant unemployment insurance benefits to Ms. Ordaz.

4. General Release. By signing this Agreement and receiving the valuable consideration described above, Ms. Ordaz hereby fully releases and forever discharges the City from any and all claims or liability of any kind, up to and including the date of this Agreement.

This release includes, but is not limited to, any claim arising under the Illinois Municipal Code; the Illinois Human Rights Act, 775 ILCS 5/1 *et seq.*; the Illinois Wage Payment and Collection Act, 820 ILCS 115/1 *et seq.*; the Illinois Public Labor Relations Act, 5 ILCS 315/1 *et seq.*; the Illinois Service Member Employment & Reemployment Rights Act, 330 ILCS 61/1 *et seq.*; Title VII of the Civil Rights Act of 1964, 42 U.S.C. § 2000e, *et seq.*; the Rehabilitation Act of 1973, 29 U.S.C. § 701 *et seq.*; the Americans with Disabilities Act, 42 U.S.C. § 12101 *et seq.*; the Genetic Information Nondiscrimination Act, 42 U.S.C. § 2000ff *et seq.*; the Family & Medical Leave Act, 29 U.S.C. § 2601 *et seq.*, the Uniform Services Employment & Reemployment Rights Act, 38 U.S.C. § 4301 *et seq.*; the Illinois Whistleblower Act, 740 ILCS 174/1 *et seq.*; all claims under 42 U.S.C. §§ 1983, 1985, 1988; all claims under the City of Batavia's Municipal Code and/or personnel policies; all tort claims; all claims based on any actual or implied contract, including, but not limited to, any employment agreement between the City and Ms. Ordaz; all claims for retaliatory discharge; all civil rights claims; all amendments to the foregoing statutes, federal common law and state common law; claims under any other federal, state or local statute, law, ordinance, regulation or order, and any claims for attorneys' fees in connection with her employment or separation from employment. It is the intention of Ms. Ordaz and the City that in executing this Agreement, Ms. Ordaz is providing a general release and that it shall be an effective bar to each and every claim, grievance, demand, and cause of action, either known or unknown, for all acts or omissions of the City and its agents, jointly and separately, individually and in their representative capacities, for any injuries suffered by Ms. Ordaz occurring on or prior to the date that she signs this Agreement.

5. Rights and Claims Excluded From The General Release. Excluded from the above release are any claims or rights which cannot be waived by law. Also excluded from the release is Ms. Ordaz's right to file a charge with an administrative agency or participate in any agency investigation. Ms. Ordaz is, however, specifically waiving her right to recover any money should any federal, state, or local administrative agency (and/or private party) pursue any claim on her behalf arising out of or related in any way to her employment with and separation of employment from the City.

6. Additional Employee Acknowledgements. In further consideration of the promises made by the City in this Agreement, Ms. Ordaz specifically waives and releases the City from all claims or rights that she might have as of the date she signs this Agreement arising under the Age Discrimination in Employment Act of 1967, 29 U.S.C. § 621 *et seq.* Ms. Ordaz further agrees that:

- (a) her waiver of rights under this Agreement is knowing and voluntary and in compliance with the Older Workers Benefit Protection Act of 1990;

- (b) she understands the terms of this Agreement;
- (c) the consideration provided in this Agreement represents payments over and above that to which she otherwise would be entitled, that the consideration would not have been provided had she not signed this Agreement, and that the consideration is in exchange for the signing of this Agreement;
- (d) the City is hereby advising her to consult with an attorney prior to executing this Agreement;
- (e) the City is giving her a period of twenty-one (21) days within which to consider this Agreement;
- (f) following her execution of this Agreement, Ms. Ordaz has seven (7) days in which to revoke this Agreement by written notice. If she wants to revoke the Agreement, Ms. Ordaz should deliver a written revocation to Director of Human Resources Wendy Bednarek at 100 N. Island Avenue, Batavia, Illinois 60510, within seven (7) days after she signs the Agreement. Alternatively, Ms. Ordaz may transmit her written revocation via email to Ms. Bednarek at wbednare@cityofbatavia.net within seven (7) days after she signs the Agreement; and
- (g) this entire Agreement shall be void and of no force and effect if she chooses to so revoke; and if she chooses not to revoke, this Agreement shall then become effective and enforceable assuming all other parties have already executed it.

7. **Neutral Job Reference.** The City agrees that if it receives inquiries about Ms. Ordaz from prospective employers, the City will limit the information provided to her dates of employment, last position held, and last rate of pay, unless otherwise required by law and as long as such inquiries are directed to the City's Director of Human Resources.

8. **Severability.** If any part of this Agreement is found to be invalid, the rest of the Agreement will remain in full force and effect.

10. **Modification of Agreement.** This Agreement may only be modified by the mutual consent of both parties and such modifications must be in writing and signed by both parties.

10. **Entire Agreement/Non-Admissions.** This Agreement resolves all matters between the City and Ms. Ordaz arising out of any aspect of Ms. Ordaz's employment by the City or arising out of any aspect of her voluntary resignation as witnessed by her signature on this Agreement and supersedes any other written or oral agreement between them. It does not constitute, and shall not be construed, as any admission of wrongdoing by either party to this Agreement.

12. **Choice of Law.** This Agreement shall be governed, construed and enforced in accordance with the laws of the State of Illinois.

MS. ORDAZ AGREES THAT SHE IS ENTERING INTO THIS AGREEMENT KNOWINGLY, VOLUNTARILY, AND WITH FULL KNOWLEDGE OF ITS SIGNIFICANCE; THAT SHE HAS NOT BEEN COERCED, THREATENED, OR INTIMIDATED INTO SIGNING

THIS AGREEMENT; SHE HAS BEEN ADVISED TO CONSULT WITH AN ATTORNEY; AND THAT SHE HAS BEEN GIVEN REASONABLE TIME TO CONSIDER THIS AGREEMENT.
